

## **Under County** Jurisdiction

The purchase of the big white and yellow building across the street from the courthouse may soon be used by the county.

The Federal Building purchase has been discussed at the Rogers County Planning Commission since last spring. The commissioners agreed on Monday to pay a a total of \$130,000, 10 percent of that already paid in the amount of \$17,000.

Commissioners agreed to a road bores on County Highway, or N. 259th E. Avenue for gas service to the Hope Acres sub division community. The Hope Acres community is two miles east of Catoosa. .Rogers County Treasurer Jason Carini requested a final transfer of temporary funds for the year of \$750,000 to the Criminal Justice Authority from the General Fund.

Legal advisor to the board Benjamin Lepak questioned if the fund is agreeable to Sheriff Scott Walton,. Undersheriff Jon Sapington agreed it is.

In other business the commissioners approved taking no action on the insurance plans for the county employees. District 3 Commissioner Ron Burrows said there is not sufficient information on the employee insurance plans to make a decision.

It was agreed to recess u;until Wednesday at 4 p.m. to meet with the Department Heads and elected officials in regard to the annual Budget Estimates of needs.

District 1 Commissioner and Chairman Dan DeLozier spoke out, "The main question we all have is "if it (the budget)is it going up or down".

In other action the com-

missioners: Agreed to move a 2005 Dodge Quad pickup from the District 2 inventory. It was agreed to take the vehicle to District One for an inspection of the worth before further disposal.

### Fed Bldg. Comes Catoosa Sales Tax Slide in Sales Tax Reverses To \$47,000 Increase

Independent Newspaper Reporter The City of Catoosa reversed last

month downward trend in sales tax receipts, posting an approximate \$47,000 increase from 2014.

The city also recorded a \$5,000 increase in its use tax collections, according to the Oklahoma Tax Commission.

Catoosa received \$462,820.84 in sales tax receipts compared to \$415,823.97 in 2014.

The city's use taxes amounted to \$25,260.84. A year ago, the city received \$20,616.72.

The collections were for the period

Aug.16-31 and Sept. 1-15. Across the county, Claremore, Foyil and Verdigris got higher amounts this year while Chelsea, Inola and Rogers County all saw smaller amounts from

Claremore's sales tax receipts amounted to \$943,884.73 while getting \$934,889.45 in 2014. Its use tax totaled \$50,407.01. In 2014 Claremore's use tax check was for \$42,484.84.

Foyil's check was for \$9,667.25. Last year, the amount was \$9,278.25. The town does not levy a use tax.

Verdigris got a check for \$39,158.64 in sales taxes, compared to \$35,870.61 received in 2014. Its use tax collections totaled \$877.62, down from \$979.79 a year ago.

Chelsea received \$8,000 less than a year ago. The most recent check totaled \$41,607.36. A year ago the check was for \$49,748.58. Its use tax also dropped from \$1,339.34 a year ago to \$1,027.09 this year.

Inola's sales tax collections totaled \$54,617.06, down slightly from \$55,867.26 received a year ago. The town's use tax collections also took a hit, receiving \$2,134.16.

In 2014, Inola use tax check was for \$5,490.02.

Rogers County collected \$1,229,325.11 in sales taxes, down from \$1,396,953.20 received in 2014. Use taxes, however, increased. This year the county got \$105,556.81, compared to \$95,751.69 a year ago.

The Tax Commission reported that

sales tax collections across the state was down \$1,555,487, going from \$140,851,009 in 2014 to \$139,695,522 this year. This year the money was sent to 514 towns and cities. In 2014, 512

cities and towns received checks. Statewide, the use taxes totaled \$10,040,704, distributed to \$391 com-

Seventy-six counties received \$29,437,490 in sales taxes while 74 counties received checks totaling \$10,040,704 in use taxes.

In Catoosa's collections, \$434,335.40 of the money was for business in Rogers

Businesses in Wagoner County within the Catoosa City Limits contributed \$28,485.44 to the total.

Use taxes collected in Wagoner County were \$989.84 and in Rogers

County they totaled \$24,271. A year ago, the sales tax collections for Roger Countians in Catoosa totaled \$394,498.14. In Wagoner County, collections were \$21,325.83. Use taxes in Rogers County \$20,171.37. Wagoner Countians chipped in \$490.35.
